TYRONE CCC REGULASTIONS 2020 FOOTBALL

(Amended Regulations)



- 1. Two groups in each division of the Adult Football League.
- 2. Division I & 2 will comprise of eight teams in 5 Group A and Group B. Division 3 will comprise of eight teams in Group A and nine teams in Group B.
- 3. There will be an open draw for both groups in each division.
- 4. The first team drawn out goes to Group A, the second team to Group B, the third team to Group A, the fourth team to Group B, and so on until all teams are drawn
- 5. Each team will have seven games, except those in Group B of Division 3 who will have eight games.
- 6. On completion of the League the top team in both groups of each division will play off for the League title, and Promotion to the next higher division, for the 2021 season (where applicable).
- 7. On completion of the League, there will be no relegation from Division1 or Division 2.
- 8. In the event that a team which tops its League group wins the championship, then the other group winner, within the division, will be promoted. The League title will still be played off for.
- 9. All games in a League round will be played simultaneously.
- 10. No changing of time or date of a fixture will be permitted, unless in very exceptional circumstances.
- 11. In the event that a new lock-down is introduced due to the COVID-19 pandemic, and all league rounds have not been completed, the 2020 league season will be declared null and void. If all the League rounds have been completed and the playoff matches are pending then these matches will be completed at the first available opportunity. If the championship has reached the semi- final stage then it too will be completed. There will be no promotion for the championship winners in the event that the Leagues have not been completed.
- 12. The winners of the Junior and Intermediate football championships will be promoted to Division 2 and Division 1, respectively, in the league for the 2021 season.
- 13. Play-off matches and all championship matches will be winner on the day using the following protocol. In the event of teams finishing level at the end of normal time, two periods each of ten minutes duration will be played. If teams remain level at the conclusion of this extra time, a penalty competition will take place in line with the 'Winner On The Day Protocols'.
- 14. County players will be available to their Clubs for all league and championship matches.
- 15. To determine final League positions, the Regulations outlined in T.O. Rule 6.21(4) (a), (b), (c) and (d) shall apply to all Tyrone Adult League competitions for 2020 season.

- 16. When teams finish with equal points for qualification for the concluding staged, or for promotion or relegation, the tie shall be decided by the following means and in the order specified:
 - The outcome of the meeting(s) of the teams in the previous game(s) in the competition
 - ii) The largest scoring difference (subtracting the total scores against from the total scores for) in the meetings of the teams in the previous game(s)
 - iii) The highest total scores for, in the meeting(s) of the teams in the previous game(s)
 - Largest overall league scoring difference (subtracting the total scores against from total scores for)
 - v) The highest overall league total score for
 - vi) A playoff
- 17. If a player has played in his clubs' last adult championship match, in which he is eligible to play, he will be ineligible to play in this years' Reserve Knockout even if the clubs' last adult championship game falls outside the current competition year.
- 18. In the event of a dispute over the interpretation of the rules of the competition the decision of Coiste Bainistí will be final.
